Description of Proposal: The Benton County Mosquito Control District 1 is proposing to conduct normal maintenance and repair of roadways, horse trails and ditches within W.E. Johnson Park. Normal maintenance and repair will include temporarily altering beaver dams, removing debris from plugged culverts, clearing brush from ditches (utilizing hand tools such as a machete or chain saw), and removing vegetation from the existing roads and horse trails throughout the park.

Flow is minimal and at most times the water does not flow. Most of the water in the park is subwater that rises and falls with the level in the Yakima River.


