ORDINANCE NO. 44-21

AN ORDINANCE of the City of Richland vacating a portion of Keene Court right-of-way.

WHEREAS, pursuant to an approved preliminary plat and the construction permit issued under Chapter 12.10 of the Richland Municipal Code (RMC), RP Development, Inc. ("Developer") is constructing Phase 1 of the Marcello Estates development (the "Development"); and

WHEREAS, the development plan for Marcello Estates – Phase 1 includes extending Keene Court, an existing cul-de-sac, to connect to a public street; and

WHEREAS, the modified street system will make the cul-de-sac unnecessary; and

WHEREAS, Developer's infrastructure construction project is anticipated to be complete in the coming months, enabling the processing of a final plat application; and

WHEREAS, vacating the unnecessary portions of Keene Court right-of-way will allow the final plat of Marcello Estates to correctly represent the long-term needs of the city street system and include lots unencumbered by unnecessary right-of-way; and

WHEREAS, state law requires that a public hearing be held to allow public consideration of this proposal; and

WHEREAS, on November 2, 2021, Richland City Council adopted Resolution No. 128-21, setting December 7, 2021 at 6:00 p.m. as the date and time for said hearing; and

WHEREAS, on December 5, 2021, notice was duly published that a virtual public hearing would be held on December 7, 2021 to take public testimony on the proposed vacation action; and

WHEREAS, on December 7, 2021, a virtual public hearing was held by Richland City Council to receive public testimony.

NOW, THEREFORE, BE IT ORDAINED by the City of Richland as follows:

<u>Section 1</u>. The portion of Keene Court right-of-way described in **Exhibit A**, attached hereto and incorporated herein by this reference, is hereby vacated subject to the provisions of Chapter 35.79 RCW.

Section 2. The City Clerk is directed to file with the Auditor of Benton County, Washington, a copy of this Ordinance and the attached exhibit, duly certified by the City Clerk as a true copy.

<u>Section 3</u>. This Ordinance shall take effect the day following its publication in the official newspaper of the City of Richland.

Section 4. Should any section or provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, that decision shall not affect the validity of the Ordinance as a whole or any part thereof, other than the part so declared to be invalid.

<u>Section 5</u>. The City Clerk and the codifiers of this Ordinance are authorized to make necessary corrections to this Ordinance, including but not limited to the correction of scrivener's errors/clerical errors, section numbering, references, or similar mistakes of form.




