AMENDMENT No.1 TO

**INTERLOCAL AGREEMENT BETWEEN THE COUNTY OF BENTON, AND:
THE CITY OF BENTON CITY, THE CITY OF KENNEWICK, THE CITY OF PROSSER,
THE CITY OF RICHLAND, AND THE CITY OF WEST RICHLAND;
FOR PROVIDING FOR LOCAL HOMELESS HOUSING AND
ASSISTANCE PLANS AND PROGRAMS**

This Amendment No.1 is to the Interlocal Agreement, recorded on March 12, 2007, among Benton County, a political subdivision of the State of Washington, hereinafter referred to as "COUNTY," with its principal offices located at Post Office Box 150, Prosser Washington, 99350; the City of Benton City, a municipal corporation with its principal offices located at 708 Ninth Street, Benton City, Washington 99320; the City of Kennewick, a municipal corporation with its principal offices located at 210 West Sixth, Kennewick, Washington 99336; the City of Prosser, a municipal corporation with its principal offices located at 601 Seventh Street, Prosser, Washington 99350; the City of Richland, a municipal corporation with its principal offices located at 505 Swift Boulevard, Richland, Washington 99352; and the City of West Richland, a municipal corporation with its principal offices located at 3801 Van Giesen Street, West Richland, Washington 99353; hereinafter all the aforementioned cities referred to collectively as "CITIES."

There parties hereto agree as follows:

1. The COUNTY and the CITIES agree that Section 4(d) of the Interlocal Agreement recorded on March 12, 2007 regarding homeless housing funds shall be superceded and replaced by the following:
 - d) The County may enter into one or more separate Professional Service Agreements with one or more independent contractors to update and implement the County's Ten-Year Homeless Housing Plan and to use funds from the County's Homeless Housing and Assistance Fund to pay for the costs thereof, in accordance with RCW 36.22.179 and RCW 43.185C.050.
2. All other provisions of the above referenced Interlocal Agreement shall be unchanged and remain in effect.




