

MEMORANDUM OF AGREEMENT BETWEEN CITIES  
OF KENNEWICK, PASCO, RICHLAND, WEST RICHLAND AND FRANKLIN  
CONSERVATION DISTRICT AND BENTON CONSERVATION DISTRICT FOR  
WATER CONSERVATION PUBLIC EDUCATION PROGRAM SERVICES

THIS MEMORANDUM OF AGREEMENT (MOA) is entered into this date by and between the Cities of Kennewick, Pasco, Richland, and West Richland, municipal corporations, (hereinafter "Quad-Cities") and the Franklin Conservation District and Benton Conservation District, governmental subdivisions of the state (hereinafter "District").

WHEREAS, the Quad-Cities and the District are public agencies as defined in RCW 39.34.020(1), who wish to enter into a Memorandum of Agreement; and

WHEREAS, In September, 2003 the Washington State Department of Ecology issued water right permit S4-30976 to the Quad-Cities; and

WHEREAS, Permit conditions require the Quad-Cities to implement a school education program; and

WHEREAS, the Franklin Conservation District and Benton Conservation District are governmental agencies currently providing water conservation education to the school districts; and

WHEREAS, the Quad Cities desires to enter into a memorandum of agreement with the Franklin Conservation District and Benton Conservation District to support the district's Water on Wheels education program for the Quad-Cities area.

For and in consideration of the conditions, covenants and agreements contained herein, the parties agree as follows:



1. DUTIES. The District will offer Water on Wheels educational program to all classrooms in Kennewick, Richland, Pasco, and West Richland through a coordinated outreach effort through the School District's Curriculum Departments. Details for the services to be provided by the District are provided in the attached Exhibit A.
2. COMPENSATION TO THE DISTRICT. The District will be paid a lump sum amount of \$10,000 for work performed from July 1, 2010 through May 30, 2011. The Franklin Conservation District will submit an invoice to the City of Kennewick in June 2011 with a report detailing the school name and number of classrooms in which the program was provided.
3. COMPENSATION FROM THE QUAD CITIES. The four cities will divide the compensation to the District based on population. The proportional split is 34.9% for the City of Pasco, 38.4% for the City of Kennewick, 22.1% for the City of Richland, and 4.6% for the City of West Richland. The City of Kennewick will

invoice the other Quad-Cities based on this proportion. Each of the Quad-Cities will pay the City of Kennewick within 30 days of receipt of an invoice from the City of Kennewick. The City of Kennewick shall be responsible for full payment to the District...


4. TERM. The term of this agreement is July 1, 2010 through June 30, 2011.
5. ADMINISTRATION. This MOU shall be administered by the City of Kennewick. Modifications to this agreement may be done by written consensus of the Quad-Cities Public Works Directors and the Districts. All reimbursement to the District shall be administered through the City of Kennewick.
6. TERMINATION. This MOU may be terminated by 30 days written notice from the party desiring to terminate the agreement with the other parties.





Proposed Work

**Overview**

Thank you for considering the Franklin Conservation District's Water on Wheels Education Program to help fulfill your information and education requirements. Water on Wheels is currently offered to classrooms grades K-12 in Kennewick. Lessons are designed to educate students about water, soil and energy conservation. The Franklin Conservation District has been providing Water on Wheels to schools since 2003. Currently Water on Wheels is available in 13 counties in Eastern Washington. All lessons are aligned with current science learning standards and are age and grade level appropriate.

2010-2011

\$10,000

- Water on Wheels will be offered to all classrooms in Kennewick, Richland, Pasco and West Richland through a coordinated outreach effort through the School District's Curriculum Departments.
- Funds will be used to hire a qualified individual who will teach the Water on Wheels Program and reach approximately 5,000 students through approximately 200 lessons.
- The Cities of Kennewick, Richland, Pasco and West Richland will be recognized as a Water on Wheels sponsor on all printed materials handed out to teachers, students and the general public.
- The cities of Kennewick, Richland, Pasco and West Richland will receive a full report at the end of the school year stating where lessons were taught as well as the number of students, teachers and lessons taught. Evaluations of each lessons will also be available upon request.

Timeline

Program work will begin July 1, 2010 and will conclude May 30, 2011. Final reports will be delivered no later than June 30, 2011.
