INTERGOVERNMENTAL AGREEMENT No. 2387

Agreement No. IG-2387 by and between the STATE OF WASHINGTON, OFFICE OF THE SECRETARY OF STATE, WASHINGTON STATE LIBRARY DIVISION ("OSOS") and RICHLAND PUBLIC LIBRARY ("Library System") is amended as follows:

**COMPENSATION**

This Agreement utilizes funds made available to OSOS from the Washington State Department of Information Services as a result of the Qwest settlement with the State of Washington.

Compensation for services shall be based on the rates attached hereto as Exhibit A, Annual Co-pay, and in accordance with the following terms:

Transport charges:

- 1.1. Bandwidth: Three T1 Equivalent Usage (4.6 Mbps)
- 1.2. Service location: 955 Northgate Drive, Richland, Washington 99352
- 1.3. Annual charge (From fee table, Attachment A): Based on actual usage measured at the 95% bandwidth level as collected by the University of Washington / Pacific Northwest Gigapop
- 1.4. Transport services are provided through the Department of Information Services.

2. Internet Connectivity:


- 2.1. Annual charge: Based on actual usage measured at the 95% bandwidth level as collected by the University of Washington / Pacific Northwest Gigapop
- 2.2. The actual charge for Internet connectivity will be based on 95<sup>th</sup> percentile bandwidth usage for the preceding quarterly period.
- 2.3. Internet connectivity is provided through the University of Washington.

All other terms and conditions of the original Agreement and amendments thereto remain in full force and effect.

## Exhibit A

**Public Libraries Connecting to K-20 Network  
Quarterly Circuit Co-pay**

Bandwidth	Circuit Co-pay	Estimated ISP Fees
1Mbps – 6Mbps	\$400/Mbps*	***
Beyond 6Mbps	\$60/Mbps **	***

\*A base price of \$1,600 will be charged for up to the first megabit. Circuit co-pays in the range of 1-6 Mbps are based on actual ISP usage measured at the 95th percentile multiplied by \$400/quarter and are independent of transport mechanism. (e.g. 1.12Mbps [\$448] = 1.12Mbps \* \$400/quarter [\$448])

\*\* Circuit co-pays beyond 6 Mbps (\$9,600) measured at the 95th percentile usage increase at \$240/Mbps per year. (e.g. 8Mbps [\$2,520] = 6Mbps \* \$400/quarter [\$2,400] + 2Mbps \* \$60/quarter [\$120]) ISP fees are charged at the current commodity price per megabit based on actual ISP usage measured at the 95th percentile.

\*\*\*ISP fees are charged at the current commodity price per megabit based on actual ISP usage measured at the 95th percentile.
