TO  
INTERGOVERNMENTAL AGREEMENT NO. IG-2387

Agreement No. IG-2387 by and between the STATE OF WASHINGTON, OFFICE OF THE SECRETARY OF STATE, WASHINGTON STATE LIBRARY DIVISION (hereinafter "OSOS") and RICHLAND PUBLIC LIBRARY (hereinafter "Library System") is amended as follows:

**COMPENSATION**

Compensation for services shall be based on the following rates and in accordance with the following terms:

1. Transport charges:
  - 1.1. Bandwidth: Two T1 Equivalent Usage (3.0 Mbps)
  - 1.2. Service location: 955 Northgate Dr., Richland 99352-3539
  - 1.3. Annual charge (From fee table, Attachment A): Based on actual usage measured at the 95% bandwidth level as collected by the University of Washington / Pacific Northwest Gigapop
  - 1.4. Transport services are provided through the Department of Information Services.
2. Internet Connectivity:
  - 2.1. Annual charge (From fee table, Attachment A): Based on actual usage measured at the 95% bandwidth level as collected by the University of Washington / Pacific Northwest Gigapop
  - 2.2. The actual charge for Internet connectivity will be based on 95<sup>th</sup> percentile bandwidth usage for the preceding quarterly period.
  - 2.3. Internet connectivity is provided through the University of Washington.


Attachment A, Annual Co-pay: Public Libraries Connecting to K-20 Network is hereby revised.

All other terms and conditions of the original Agreement remains in full force and effect.

Quarterly Circuit Co-pay**

Bandwidth	Circuit Co-pay	Estimated ISP Fees	Estimated Total Charges
1/4 T1	\$156.25 (\$625/yr)	\$30*	\$186.25
1/2 T1	\$312.50 (\$1,250/yr)	\$60*	\$372.50
1Mbps – 6Mbps	\$400/Mbps	**	**
Beyond 6Mbps	\$60/Mbps	***	***

\*Figures for ISP co-pay are estimated and for budgeting purposes only. Actual ISP co-pay will be based on bandwidth usage at the individual participating library system.

\*\* A base price of \$1,600 will be charged for up to the first megabit. Circuit co-pays in the range of 1-6 Mbps are based on actual ISP usage measured at the 95th percentile multiplied by \$400/quarter and are independent of transport mechanism. (e.g. 1.12Mbps [\$448] = 1.12Mbps \* \$400/quarter [\$448]) ISP fees are charged at the current commodity price per megabit based on actual ISP usage measured at the 95th percentile.

\*\*\* Circuit co-pays beyond 6 Mbps (\$9,600) measured at the 95th percentile usage increase at \$240/Mbps per year. (e.g. 8Mbps [\$2,520] = 6Mbps \* \$400/quarter [\$2,400] + 2Mbps \* \$60/quarter [\$120]) ISP fees are charged at the current commodity price per megabit based on actual ISP usage measured at the 95th percentile.
